1. WHO ARE WE?

TALENT ALL ACCESS® PORTAL+ is a portfolio of data products that cover a range of human resource topics such as benefits and compensation accessible via an online portal (the "**Platform**"). The Platform includes a chatbot functionality, designed to support your use of the Platform ("**Aida**").
